


Figure 1 Suggested drawing

# 7.0 Annexure-1: Application Description

Gyrotron is a vacuum electronics device used for generating high power high frequency RF power. In order to assist the thermionic emission of electrons in tube, its filament must be energized to high temperatures. As this filament located close to the cathode and is referred to the cathode potential which is at the accelerating voltages of ~55kV DC. As this is unusually high voltage the filament power supply, which is generally referred to ground, must be isolated with filament which is floating at high voltages. In order to meet this isolation and electrical power requirement tube a stepped-down, Isolation transformer is required with specifications prescribed latter.

A schematic of the Gyrotron and its assembly is shown below for reference:




Figure 2 Schematic Circuit arrangement of the GYROTRON Tube




Figure 3 Schematic circuit of the Filament Power Supply Unit.
