## 1) INTRODUCTION:

"ITER-India Sangath Office Building is located at Bhat-Koteshwar Road near Sangath Skyz. "Godrej" make Fire Detection and Alarm System are already installed in our office Building. Total 74 nos. smoke detectors, 02 nos. heat detectors, 05 nos. of isolators, 05 nos. hooters, 05 nos. FCM, 03 nos. of Manual call points (MCP) and 01 no. Main Fire Control Panel (NFS-320) installed.

The scope includes the 'All in All Comprehensive service and maintenance with spares (including breakdown services and all kind of spares) to be carried out for the Entire Fire Alarm and Detection system located in ITER-India office building.

## 2) EXPERIENCE AND QULAIFYING CRITERIA:

The qualification criteria for the evaluation of bid are as under: -

- i. The bidder shall have experience of inspection, testing, servicing, and maintenance of Fire Alarm System (FAS) for at least one of the well-reputed organization. This contract must not amount to less than Rs. 50,000/- per annum within the period of last three financial years i.e. 2019-20, 2020-21 & 2021-22. (Bidder shall submit at least one copy of work order and satisfactorily completion certificate from the respective organization.)
- ii. The bidder shall have at least one ongoing contract of similar kind of AMC work of Fire Alarm & Detection System having similar or more equipment. (Bidder shall submit a copy of work order from the respective organization)
- iii. The bidder should have at least one of its service centers located in Ahmedabad / Gandhinagar equipped with adequate infrastructures to satisfactorily execute the CMAC contract. (Bidder shall submit proof of having service center in Ahmedabad/Gandhinagar).

#### 3) SCOPE:

## INSPECTION, MAINTENANCE AND SERVICING OF FIRE ALARM & **DETECTION SYSTEM:**

- i. Annual comprehensive maintenance & service contract covers all-in-all service & maintenance of control panels with all the components, zone circuits with cabling, power circuit with cabling up to power source for the system, detectors, manual call points, batteries, hooters, isolators, FCM modules etc. related to Fire Alarm system installed at ITER-India Office building. Maintenance is to be carried out as per IS 2189:2008.
- ii. There shall be total Four preventive maintenance service in a year (i.e. once in a three months' period). The bidder also provides breakdown services as and when required on call basis at no extra charges. The preventive maintenance includes following works:

#### Fire Control Panel:

- Check any system related error message on control panel.
- Check all function working properly or not like RESET, FAULT, ISOLATE, RESET, SILENCE etc.
- Carry out lamp test and check all LEDs are working or not.
- Check the continuity of all cable termination and joints.
- Check the battery for its terminal voltage and charging/discharging.

### **Smoke & Beam Detector:**

- Clean the dust/dirt from all detectors.
- Check the tightness/alignment of terminal connection of detector base.
- Check detector's LED functioning.
- Check the sensitivity of detector.
- Test the function of detector by actual smoke or remote test after maintenance.

## **Manual Call Point:**

- Check the activation knob.
- Check functioning of manual call point.

#### Hooter:

Check the activation of siren with strobe light,

Check function of isolators and FCM modules working properly

- iii. Main fire alarm panel (NFS-320) including all spares in panel should be covered under CAMC. in case of major fault in Main Fire Panel Contractor needs to arrange alternate panel or arrangement for continuous operation of FAS panel.
- iv. Maintaining the system in proper operating condition by regular & systematic examination, repairs/replacement of all the components of fire alarm system and necessary spares like LED's, PCB's, & any other components of fire alarm system required to keep system in healthy working condition.
- v. Replacement of required spares shall be of identical make & standard. Approval shall be taken from Engineer In-charge for any item needs to be replaced before installation.
- vi. The bidder shall submit the Service and Maintenance Report along with Checklist as per (Annexure-I) within one week to the Engineer in-charge after each service.

## 4) **SAFETY CODE:**

- i. The contractor shall cover his employees/workers under PF, ESI, personal accident insurance policy and applicable laws. Contractor has to submit PF details, ESI No. and insurance policy documents of all employees before commencement of the work.
- ii. The contractor shall be fully responsible for the behavior, conduct, theft and any breach at security etc. by his personnel and workers.
- iii. The contractor shall comply with all Govt. rules & regulations for his staff in regard to maintain the applicable labor laws, their amendments etc. in force from time to time.
- iv. The contactor shall comply with the instructions given by the engineer in charge, regarding safety regulations, safety precautions, protective measures, clean-up practices, housekeeping etc.
- v. The contractor shall ensure adequate safety precautions at site as required under the law of land. Contractor must be entirely responsible for safety of their personnel and provide them safety helmets, safety shoes, other safety gadgets as required and prescribed.

## 5) TERMS AND CONDITIONS:

- 1. The mentioned work shall be carried out under direct supervision of responsible person along with at least two trained persons of the contractor and in the presence of engineer in charge. Change of personnel who carries out the services shall not be allowed.
- 2. Care must be taken while carrying out the job to avoid any damage to equipment & property of ITER-India. Contractor has to pay for the cost of damage.
- 3. The schedule to carry out checking and maintenance of fire alarm & detection system shall be fixed at least seven days in advance by the contractor and engineer in charge with mutual agreement. Any change in schedule must be intimated three days in advance.
- 4. Contractor shall be allowed to execute the work from 9.30 a.m. to 5.30 p.m. on all working days.

- 5. Contractor shall respond promptly for any communication made by ITER-India via letter, e-mail or any other mode.
- 6. In case of servicing, checking, repairing of the system is not carried out as per the schedule, proportionate deduction in payment will be done from the bill.
- 7. In case the contractor fails to carry out the work as per specified scope of work, ITER-India reserves the right to terminate the contract & get the work done from any other party at the risk & cost of contractor.
- 8. In case of failure to execute the scope of work and obey safety code by contractor, ITER-India shall issue the show cause notice. If found guilty, the contractor shall be penalized for Rs.1000/- (Rupees One Thousand only) that shall be deducted from the payment due for the work. Work order shall automatically get void if the penalty imposed for three times.
- 9. The contract shall for the TWO YEAR only.
- 10. Preventive maintenance shall be carried out once in every three months and check lists shall be filled in the formats supplied by AMC Contractor. The contractor has to carry out monthly cleaning of parts/ covers with appropriate non-corrosive cleaner and periodic testing of system for their functional condition.
- 11. Logbook shall be maintained for Fire Alarm & Detection System and the list of work carried out like servicing, maintenance, repairs etc. shall be recorded systematically on a regular basis. The recordings in the logbook shall be got endorsed by the Engineer from time to time and verified by the Section Head/Division Head. The Logbook shall be the basic record for all purposes.
- 12. The Contractor/Service Provider firm agrees that have adequate technical expertise/ field experience/ infrastructure facilities/ spares in stock/ business arrangement with OEM/ back up facilities, statutory government approvals/ registrations. Documentary evidences will be produced on demand.
- 13. The Contractor shall keep enough spares and consumables in stock to meet the requirements during the period of contract.
- 14. The Contractor shall use only genuine original parts. If it is found otherwise, it will be termed as a breach of contract. The faulty parts of the FAS shall be replaced with new one of the same or higher rating/ configuration and of the OEM or reputed brand. In case of replacement of defective parts, the part should be accompanied with proper challan mentioning details of part replaced. In support of this successful bidder will have to submit the cash memo/ bills from the OEM or reputed brand.
- 15. In case, if the original manufacturer does not exist or particular item is phased out, then the other available makes or model of the parts shall be got approved from the concerned engineer or Section Head / Division Head and installed at no extra cost.

- 16. ITER-India shall not be responsible for the safety of material brought by the contractor to ITER-INDIA in connection with the contract. The contractor shall be fully responsible for the safe custody of his material.
- 17. The contractor shall obtain Gate Pass from ITER-India Lab for taking out his material from ITER-India/IPR campus. Contractor shall not be allowed to take out any material including his material without a valid Gate Pass to be issued by Section Head / Division Head or Stores in charge. Normally the Contractor shall not be allowed to take out any material on holidays and before 10.00 Hrs. and after 5.00 p.m. on working days.
- 18. All the materials brought to ITER-India Lab/IPR campus in connection with the work contracted to the Contractor are to be routed through ITER-India Stores with supporting delivery Challans in triplicate indicating full description, quantity, value etc. This procedure should be followed strictly during the contract period.
- 19. Notwithstanding as to what is specifically stated, it shall be the responsibility of the contractor to attend to all the preventive maintenance/routine maintenance and repairs and breakdown services including replacements of all parts/components.
- 20. The repairs must be carried out without damaging other working parts of FAS.
- 21. ITER-India will not supply any tool / tackle / equipment. After satisfactory completion of each of the work, the Contractor shall get approval from Section Head/Division Head. In case any spares parts, equipment or accessories which supplied by ITER-India during the maintenance/ repairing/ service purpose on temporary basis, the contractor will be responsible for it and has to return back to ITER-INDIA in good condition.
- 22. Normally repairing and replacement works should be done at ITER-India Campus. However, if it is to be taken outside ITER-India campus to and from transportation charges including any other charges like transit insurance etc. shall be borne by the contractor.
