**Re-engagement of retired DAE employee  
as Consultant Draughtsman on contractual basis**

(Only employees retired on superannuation from the Department of Atomic Energy (DAE) and its Units including Autonomous Institutions are only eligible to apply)

- 1) Applications are invited for performing various duties such as preparation of 3D Models and 2D drawings for concept and detailed models using CATIA and Mechanical Desktop.
- 2) Retired employees meeting the eligibility criteria, who are willing to perform the above work can submit their applications in the prescribed format along with the passport size photograph duly affixed and a copy of the Pension Payment Order.
- 3) Applicants should have retired as '**DRAUGHTSMAN**' from DAE and its units including Autonomous institutions.
- 4) The applications received will be scrutinized by the Competent Authority and the selected candidate will be communicated, the date of commencement of work and the period of tenure.
- 5) **Eligibility criteria:**
  - 5.1 Applicant should have retired from the Department (DAE or its constituent Units) including Autonomous Institutions under DAE on superannuation.
  - 5.2 Applicant should have requisite experience and knowledge of working on CATIA and Mechanical Desktop.
  - 5.3 Applicant should be medically fit and required to submit Medical Fitness Certificate at the time of the engagement.
- 6) The period of engagement shall be initially for one year and further extendable for one more year or upto the date of attaining the age of 64 years, whichever is earlier. The engagement shall be purely on contract basis and can be terminated at any time by ITER-India without assigning any reason.

**Entitlements:**

- 6.1 The official on re-engagement is entitled to draw 50% of the last pay drawn.
- 6.2 12 days of leave in calendar year on pro rata basis is admissible for re-engaged officials.

- 6.3 If required to travel outside Headquarters (Ahmedabad/Gandhinagar) in connection with the work. TA, DA admissible to regular employees working in the same grade from which the official has retired, will be admissible.
- 6.4 Re-engaged officer shall not be entitled for any allowances (HRA, CCA, TA, DA etc.)
- 6.5 Re-engaged officials will not be entitled to contribute towards GPF, Gratuity, NPS etc. for the period of re-engagement.
- 6.6 No transport facility will be provided for commuting to office.
- 7) The place of work will be ITER-India, IPR.
- 8) The Consultants need to perform the duties for 08 hrs 30 minutes per day on all working days.
- 9) This Department has right to reject any application without assigning any reason.
- 10) Last date for receipt of application is **08 Dec 2022**
