- 1. The quotation and any order resulting from this enquiry shall be governed by our Conditions of Order and supplier quoting against this enquiry shall be deemed to have read and understood the same in to
- 2. Where counter terms and conditions have been offered by the Tenderer, the same shall not be deemed to have been accepted by ITER-India unless our specific written acceptance thereof is obtained.
- 3. Quotation: Your quotation superscripting our enquiry No., date, due date and brief description of item should be submitted to the Purchase Officer, ITER-India in sealed envelope on or before the due date tate/ belayed/incomplete quotations will not be considered. Envelopes received without Enquiry number, date, due date and brief description of item may be rejected. The quoted prices should be firm for a period of 90 days from due date for placing order. ITER-India is not bound to accept lowest rate/s. aidder shall submit the price bid/offer on bidder's letter head with official seal and sign on each page.
- 4. The bid documents shall be prepared in English language only
- 5. All pages of the bid documents shall be numbered. Each page of the bid document shall be stamped and initialized.

- 21. No correspondence will be entertained within 30 days from the date of receipt of material and bills, whichever is later,
- 22. Guarantee: The Stores/Items offered should be guaranteed for a minimum period of twelve months from the date of acceptance, against defective materials, design, workmanship, operation or manufacture. For defects noticed and communicated during the Guarantee period, replacement/rectification should be arranged free of cost within a reasonable period of such notification. In case where our specifications call for a guarantee period more than 12 months specifically, then such a period shall apply.

Annexure-A

Electric Torque Wrench Service for bolting and tightening of INTF top lid

1) Scope of Work

Scope of the work is to provide necessary bolting solution for closing the top lid of INTF vessel. INTF vessel is a cylindrical SS vessel with length 8 m and height 5 m with rectangular opening on the top. The bolting is done with M30, 76 bolts of the circumference of flange as shown in figure 1,2. The sequence of the bolting service as follows

- a) Loosening the M30 bolts with hexagonal bolt head. (Maximum no of bolts to be loosened is 76 Nos)
- b) Tighten the bolts with torque ranging from 500 Nm to 1500Nm. (Maximum no of bolts to be tightened is 76 Nos)
- c) Sequencing the bolt tightening to reach satisfactory sealing of vessel flange and top lid flange.

2) Additional requirements

- The scope should be considered as lump sum work. Quote should be based on the lumpsum work to carry out the whole scope of work.
- Man power and tools should be the responsible of the vendor. Planning should be done as 8 hr shift on weekdays. Electric torque wrench with adjustable torque range is advisable for the work
- Sequencing and amount of torque with in the described range can be determined by he vendor to attain the proper scope of work.
- Safety should be paramount during the activity. All the safety accessories to be provided to working personnel should be responsibility of vendor. A supervisor should be available to supervise the work activity. The work should adhere to ITER-INDIA, IPR safety rules& principle.
- Vendor should take care that no items are damaged during the scope of work. Particular care to be taken to not to damage the bolts.
- After the scope of work, Report on final torque setting of bolt and sequencing to be provided to Iter- India, official.
- Bolt type: Hexogonal head, Material: SS304L, No. of Bolts: 76, M30Max. Torque limit: 1500
 Nm

4) SAFETY CODE:

- 1. The contractor shall cover his employees/workers under PF, ESI, personal accident insurance policy and applicable laws.

The Supplier shall be responsible and accountable for the proper behavior of the staff employed by him and also for any breach of security regulations, thefts, sabotage etc. The Supplier shall withdraw any person so desired by ITER-India/IPR, if in the opinion of the representative of ITER-India/IPR it is not desirable to permit that particular person to work inside the campus.

6) Accident/Third Party Liability:

The Service Provider will take all possible precautions to avoid damage to the Purchaser's property during its onsite activities. Service Provider shall also take insurance covering third party liability for the personnel and Equipment's and/or tools deployed at Purchaser's site against all risks, such as injuries, loss of life etc. Service Provider will be fully responsible, accountable and liable for payment of compensation. In the event of loss and/or damage to Purchaser's property / any item(s) / equipment and/or injury or loss of life to Purchaser's personnel during the course of onsite activities due to the Service Provider's default. Service Provider will be fully responsible, accountable and liable for such damages and/or losses and payment of appropriate compensation as assessed by the Purchaser. Service Provider will relieve the Purchaser from all the risk and liabilities under this clause.

7) Limitation of liability

Except in cases of criminal negligence or willful misconduct, the aggregate liability of the Contractor to the Purchaser, whether under the CONTRACT, in tort or otherwise, shall not exceed the total CONTRACT price.





